# 1 5i Cloud Acceptable Use Policy

The Cloud Acceptable Use Policy ("Policy") outlines acceptable use of the 5i Cloud services which interact with, or access, the internet (the "Services"). This Policy is in addition to any other terms and conditions under which 5i provides the Services to you.

5i may make reasonable modifications to this Policy from time to time by posting a new version of this document on the 5i website. Revisions are effective immediately upon posting. Accordingly, we recommend that you visit the 5i website regularly to ensure that your activities confirm to the most recent version.

Questions about this Policy are not exhaustive. Prohibited uses and activities include, without limitation, any use of the Services in a manner that, in 5i's reasonable judgment, involves facilities, or attempts any of the following:

- any illegal or fraudulent activity;
- to violate the rights of others;
- any content or activity that promotes pornography and or child sexual exploitation or abuse;
